7. TRUSTEE REPORT: October 2020

The regularly scheduled Board meeting was held September 28 th and was live streamed.

DIVISION GOOD NEWS:

St. Kateri, the new K-5 School in Morinville hosted their official opening on October 8 th . Due to COVID, the

official ceremonies were streamed for the families and into each of the classrooms. Dignitaries present

included MLA Dale Nally, Mayor Turner and a couple Councilors from Morinville, Mayor Hnatiw from Sturgeon

County, The architect, builder, interior design personnel. The school was blessed by Bishop Terrio of St. Paul,

Elder Edna Arcand offered a blessing in Cree and Dallas Arcand, Three-time World Champion Hoop Dancer,

performed.

Berth Kennedy and Sister Alphonse Academy received funding from the city of St. Albert's Environmental

Initiatives Grant Program. BK received \$4,000 towards an outdoor learning space. Sister Alphonse received \$2,000 to design an outdoor learning garden space.

Legal School did a project for Hope Mission, collecting pajamas, underwear and long underwear for the less

fortunate.

The COVID school reentry plan is reviewed regularly and revised as needed.

PRESENTATION DELEGATION:

Changes/updates to the policies made were to reflect the new Education Act and

Superintendent Leadership Quality Standards.

ii) Board Policy 22 Added: Under the Education Act, each School Division has until December 31 to

write a Board Policy determining the number of Trustees and Ward Distribution (if applicable).

Given GSACRD's Rural-Urban configuration, we have allocated three wards with 7 Trustees total.

- 4 Trustees from St. Albert Ward and parts of Sturgeon County
- 2 Trustees from Morinville Ward and parts of Sturgeon County-west
- 1 Trustee from the Legal Ward includes Bon Accord and parts of Sturgeon County.
- iii) Alberta School Board Association Award.

Nominations: Town of Morinville (Friends of Education Award).

iv) Revision to and approval of 2020-2021 Board Meeting Schedule adding in a Committee of the Whole

Meeting in November.

v) The Board approved the appointments for school council liaisons for the 2020-2021 school year will

hopefully be completed at the next meeting once all the meeting dates have been sent in.

vi) Discussion around different options for executing Public Board Meetings on-line during these times of

COVID-19. Rudy Zacharias, Manager of Communications and Community Engagement will bring back cost

estimates on options at the next meeting.

### SUPERINTENDENT'S REPORT

- i) PUF (Program Unit Funding)
- Funding for 2020-2021 cut across the province. Impact to GSACRD was a decrease from \$2.4

Million to \$700,000 this academic year. The government also changed the coding of children and reduced the per-child funding from \$25,000 to \$10,000. Funding also ceases

after pre-kindergarten and is no longer carried into kindergarten, even for coded children.

- These cuts have turned our program upside down and has caused a wait list for pre-k.
- ii) St. Albert Catholic High School renaming.
- The Board reviewed the public feedback on the two name proposals that were put forth.

They were:

École St. Albert Catholic High School

École Secondaire Catholique St. Albert Catholic High School

From the Community Consultation, a third potential name emerged,

École Secondaire St. Albert Catholic High School

The renaming has been deferred to the October meeting. Cost estimates will be brought back for the Board to consider.

### **BOARD INITIATIVES:**

Trustees held their annual retreat October 2 nd. The retreat had been cancelled in the Spring due to COVID.

This year was reduced to one day and main topics were,

- Board Advocacy Plan (prioritized).
- Three Year Education Plan was reviewed through 2022-2023.

Annual General Meetings for both the Alberta Catholic School Trustees Association and the Alberta School

Boards Association of Alberta, will be held virtually in November.

Trustees will also be involved in audit meetings to close out the 2019-2020 fiscal year end in November.

#### OTHER ITEMS:

The Greater St. Albert Catholic Education Foundation held their AGM on September 24. Two Scholarships

were awarded as well as the applications for Funded School Projects were opened for application. Applications

close mid-November. The Foundation will be holding a 50/50 on-line draw as their last two in person fund

raisers were cancelled due to COVID. The 50/50 draw should launch October 26 with a plan draw date of

December 7. Minimum prize will be \$4,000 with the pot potentially climbing to \$10,000 – just in time for

Christmas.

Committee of the Whole Meeting was held on Monday, October 5, 2020.

The next Regular Meeting of the Board is scheduled for Monday, October 26, 2020, 3:30 pm and will be

streamed live.
