

## Chair Report – Feb 10, 2021 School Council Meeting

#### Council of Council Meeting – Feb 1, 2021

- All Chairs of school councils in GSACRD invited to participate in a meeting with the Superintendent and Trustees.
- Virtual meeting was very successful it was the first time in history all school councils in the district were present, as were all of the trustees. This may be the way to continue even after the covid restrictions are lifted.
- Topics focused on: by-law updates, position terms, fundraising ideas, staff appreciation ideas, Superintendent update, insurance for fundraising societies, and roundtable sharing.
- Introduction to Dr. Clint Moroziuk, GSACRD's new Superintendent
- SAA was recognized for it's involvement in the School Health Snapshot so thank you to staff and all who were involved in helping the district pass with flying colors.
- Relating to the cost of insurance the company that the district worked with in the past to provide insurance worked with the district to hold the fees to last year's rate. All schools are feeling this and there is a recognition of needing to fundraise to fundraise. To be more transparent about this, other chairs suggested a voluntary fee per family at the beginning of the year to cover this cost. School Council's liability is covered by the school because of Administration's oversight, whereas directors of fundraising societies are not covered and is required to carry insurance. The advice provided by the group was insurance is very important to societies to have insurance. I see some slippage here if this is not coordinated by the district. If SC's have their own bank accounts then the school board can legally take funds from school council accounts. Many have been switching over to a friend's society because then your fundraising funds are protected. This doesn't affect SAA. However, this opens the question as to who gets to make the decisions about the use of the funds? Should it be solely voted by a few of the society's directors or should parents at school council have a vote?
- There was general consensus that this meeting provided a lot of value because of the sharing of information and participation by all.
- Cathy Stefner, Chair of SACHS, chaired the CoC meeting. This will be her last year when her youngest graduates after 19 years of service in the district. She is a past recipient of the Parent of Distinction Award.
- The next meeting is scheduled for May. It's been years since CoC has had 2 meetings, try for 2 and hopefully get 1, but there are some years it may have been missed completely.
