Board of Trustees Report: February 2021

Our regularly scheduled Board meeting was held January 25, 2021.

Good News:

Ecole Secondaire St. Albert Catholic High School community donated almost \$20K in gifts, gift cards and food items for families in need in their own school community. Christmas Hampers were put together and delivered by staff. The school community generosity and compassion helped make Christmas a little brighter for those families.

As part of their Advent retreat, students at **Betha Kennedy** created homemade Christmas cards and hand delivered them to all their neighbours surrounding the school. Many phone calls, emails, FB messages and even a letter to the Editor of the Gazette were received, thanking the BK students for being so thoughtful. As part of **BK's** building positive community relations, Students created gift bags with a "virtual" hug included for their senior friends at River Ridge Seniors Community.

Legal School again contributed to their town-wide Christmas Hamper drive coordinated by the Emile Men of Service (formerly the Knights of Columbus) in conjunction with Ecole Citadelle. 23 Hampers were made for families in the community with a full Christmas meal, presents and food beyond the Christmas season.

Legal School's grade 5/6 class organized a service project in December as part of their Global Read Aloud project. Their book, "Indian No More" by Charlene Willing, dealt with the topic of racism towards Indigenous Peoples so the students wanted their service project to address tolerance and acceptance. The class chose to support the Centre for Race and Culture in Edmonton in their work to promote inclusion and a society free of racism and discrimination. The students created a "Maker" store and sold homemade crafts, ornaments and toys to other students in the school as well as collecting bottles from home throughout December. They raised over \$350 for their project.

Sister Alphonse Academy were awarded a grant of \$1,000 from United Way – Denton's Make your Mark on Poverty Initiative. **SAA** is organizing a virtual auction to raise dollars to support vulnerable youth (Catholic Social Service). Their virtual auction will take place in March. The school have started collecting donations for this exciting event.

Sister Alphonse Academy were awarded \$2,350.00 from the Greater St. Albert Catholic Schools Education Foundation to put towards the purchase of technology. Six new Chromebooks and a technology tub from the Learning Technology Services Department have been ordered to assist with student participation.
